

## LETTER FROM THE PRESIDENT

Dear Friend of St. Francis de Sales School:

Last summer, the six student leaders who attended the National Salesian Leadership Camp returned with a theme for the school year. Taking a much longer quote from St. Francis, they decided on the concise five-word maxim, "Change You, Change the World." The students have used it throughout this school year to regularly call to mind the need for personal change, which leads to greater change.

As I reflect on our school and our progress, I see the same correlation. Through our strategic plan, Boldly Beyond, we have set a course for transformation that allows us to see a greater change. Each of the elements of the plan asked for change in how we do things. Admissions and Marketing Initiatives are changing the way we engage prospective students and tell our story. We also have gained critical research to better understand our audience and community. Our Development Initiative has seen a complete redesign of the entire department which creates better efficiency to serve our generous benefactors. The Alumni Initiative strives for deeper connections between Alumni and the School. The Balance Sheet Capitalization Initiative has allowed us to streamline our financial systems and processes which has proven critical in our efforts to effectively forecast and project enrollment, financial aid, and overall budget. A Facilities Initiative which has many potential components, has been part of a continual study. As a result of what we have learned from the new data obtained from the continual studies, we have been able to forecast and can plan better for our future, rather than react to trends, both in terms of number of students and programming.

Since we began these changes of Boldly Beyond, we have seen much fruit, which in turn creates a greater change in our world. Each of the last three years, we have experienced growth in our enrollment; the only area Catholic school to do so. Our seventh and eighth grades, which we added just two years ago, have tripled in size! Our admissions team reports that our incoming freshmen class could exceed 180 young men. The combined impact of these growth elements creates an opportunity to rethink our physical space and footprint. Who would have thought we would be discussing the need for more classroom space just a few years ago?

The biggest change brought about in the Boldly Beyond plan is our Salesian Leadership Initiative and this year it has been launched in a big way. In addition to three grade-level modules in learning, in November we held what will become an annual Global Salesian Leadership Symposium at the Seagate Center. Many prominent alumni from near and far reconnected with our upperclassmen to share their experience of Salesian virtues in their professional and personal lives. The buzz from this single day event has been momentous! With a full-time director of the SLI on staff now, we can engage our students in the everyday opportunities to grow in humble confidence, authentic relationships and servant leadership.


We continue to experience tremendous success in our academic endeavors and our athletic teams. A couple athletes from the Class of 2017 experienced the very rare feat of being in the state semifinals or finals in hockey and lacrosse for seven of the eight seasons they competed!

## LETTER FROM FOUNDATION CHAIRMAN

Dear Friend of St. Francis de Sales School:

As you read through this Annual Report you will readily realize how much good has happened at St. Francis over the past year. Having served at this school since 1974, I am in humble awe at how much God has blessed us through the years. While from its beginning St. Francis has been an excellent school, I attest from personal experience that every year we become a more exceptional Catholic school. Among God's greatest blessings, of course, are the good people whom He has sent to collaborate with us Oblates of St. Francis de Sales giving of their time, treasure, and talent.

It is now more than two years since I retired from the position of President of our School. Having done so, my primary work at this time is to serve as Chairman of our Foundation and assist in our development efforts. The primary purpose of our Foundation is very simple: To assist the educational programs offered by St. Francis de Sales School and to assist in providing funds for scholarships and tuition assistance.

The Foundation began very modestly in the 1980's with a corpus of less than \$300,000. Total scholarship and tuition assistance awarded then was only \$16,000; today it is close to \$2 million. Over the years we have grown the Foundation to a corpus of \$12,519,820. While the growth has been dramatic, nevertheless with a five percent distribution policy, the same as in the mid 1980's, there remains a significant shortfall for the scholarship and tuition assistance needs of our students and families. A corpus of \$20 million will provide a \$1 million annual distribution; we need a distribution of \$2 million to cover our needs. We are optimistic, knowing that seventy-seven of our

alumni and friends have already made an unrealized planned gift to the Foundation and we are working to secure even more.

Oftentimes I have said that our School, with a primary purpose of guiding boys on the journey to becoming Christian Gentlemen, is more important today than in 1955 when doors were first opened to students. Sixty-three years ago this great enterprise was undertaken with the grace of God and the generosity of benefactors. More than a half century later, we continue to flourish with the grace of God and the generosity of our benefactors.

Thank you for all that you do to partner with us in our pursuit of excellence and to ensure this great mission for generations to come.



## *Contributions Report*

A gift directed toward the Boldly Beyond Initiatives will generally be utilized over a specific period of years.

Gifts to the Foundation ensure the long-term sustainability of Catholic Education at St. Francis de Sales School.


An investment in the Foundation relieves the dependence on raising significant annual operating support. Gifts to the Foundation are generally held in perpetuity and invested to provide an annual income stream for the benefit of St. Francis and its students. Foundation gifts may be used for unrestricted support or may be used to establish a named fund to provide support for a specific purpose directed by the Donor. Memorial, Estate, and deferred gifts are generally directed to the Foundation to ensure that all young men have the opportunity to attend St. Francis and not be hindered by financial limitations.

A significant portion of the Annual Fund and annual budget support is allocated towards tuition support. The chart below represents how many of our young men are the grateful beneficiaries of your generosity and financial support. Without your support, many deserving young men would not be able to receive a Knight education and make a difference in the world.

- Rev. George P. Shugrue, O.S.F.S., was the second principal of St. Francis de Sales School, serving from 1961 until 1967.

### THE REVEREND WILLIAM J. WARD SOCIETY (\$15,000-\$49,999)

- Rev. William J. Ward, O.S.F.S., was the first principal of St. Francis de Sales School, serving from the School's opening in 1955 until 1961.

### ST. FRANCIS DE SALES SOCIETY (\$5,000-\$14,999)

- St. Francis de Sales, patron of the Oblates of St. Francis de Sales School, lived from 1567 until 1622. He was the Bishop of Geneva and is known as the Gentleman Saint. The personal motto of St. Francis is the same as the School motto, *Suaviter et Fortiter*.


## Oblate History

The Oblate Fathers were founded in 1876 by Father Louis Brisson at the encouragement of Sister Mary de Sales Chappuis. While the Oblate roots stem from France, the religious order migrated to Holland, Germany, Austria, and Switzerland in the late 1800s. It was in 1893 when the Oblates first settled in the United States, first in New York and later in Wilmington, Delaware. It was here that the first permanent Oblate community and school were established. Toledo became home to the Oblates in 1943 when seven Oblates accepted faculty positions at Central Catholic High School.

Central had a serious crowding problem and Bishop George Rehring was interested in providing an all-boy high school for the community. (There were already two all-girl high school options available.) He asked the Oblates if they would be willing to take on this challenge. The Oblates agreed to build, maintain, and staff the school. St. Francis de Sales High School opened its doors to 290 freshman and sophomore students on September 14, 1955.


