Letter from the President

Dear Friend of St. Francis de Sales High School:



The 2013-14 school year, the subject of this Annual Report, was a defining year for St. Francis de Sales High School. At a time when many religious congregations are leaving their ministries, especially Catholic schools, the Oblates of St. Francis de Sales have renewed their commitment to the leadership of this school.

As most know, at the end of the 2014-15 school year I shall step aside from the office of the President of St. Francis. Our Provincial Superior and the Board of Trustees, in January of 2014, named Fr. Geoffrey Rose to succeed me as President of our school. He and I are

working this year with a consultant to ensure a structured and successful transition of leadership for this outstanding institution.

The Oblates have a commitment not only for the leadership but also for the staffing of St. Francis; there are eight Oblate priests teaching and ministering at the school. We have more priests in our school than there are in all the other Catholic high schools in the Diocese of Toledo combined! As noted above, the Oblates of St. Francis de Sales have renewed their strong commitment to St. Francis de Sales High School, the commitment they made when the doors first opened in September of 1955.

Even as I leave the office of President of St. Francis, my intention is not to retire but, rather, to disengage from the daily life of the school in order to give my attention and energy to building our endowment and working to ensure our school's financial stability for future generations. A stark reality is that education at every level, i.e., elementary, high school, college, and graduate school, has outpaced inflation for several years. I firmly believe that private high schools, like private colleges and universities, need strong endowments to carry on their missions in future years. And the mission of St. Francis de Sales High School is too important, too necessary, not to endure!

This Report will provide you with a picture of our accomplishments and finances over the past year. I hope you realize that we are responsible stewards of your support and, having read this letter, I hope you realize our school has a strong and solid future. Thank you for your generosity, your partnership, in helping us to realize our mission.

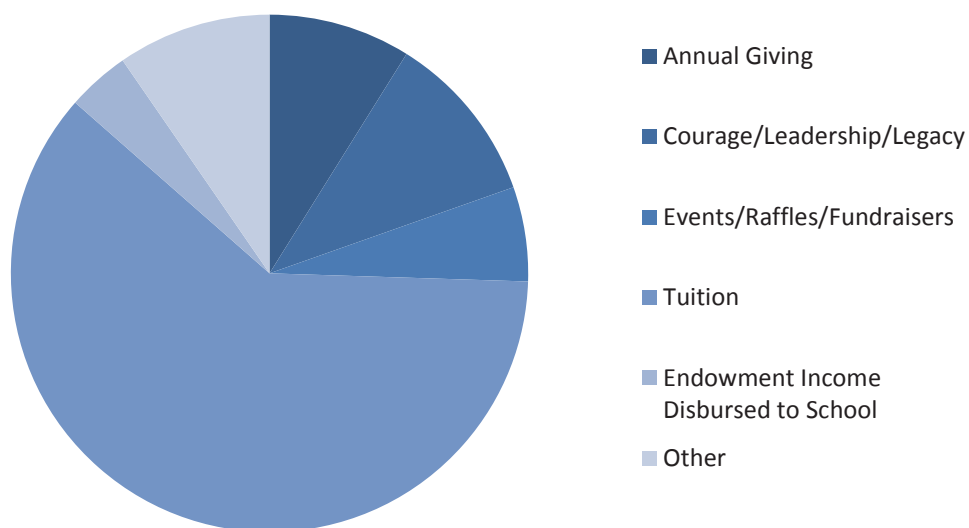

Sharing the Vision of Fr. Olszewski:

Tuition Revenues + Annual Giving + Endowment Income + Other = Operating Budget

That is a model that is similar to most all Catholic/Private high schools across the country. The only real difference is that at many of the private schools, tuition revenues cover a majority of the operating budget. This, of course, has never been true at St. Francis. From the time the school opened in 1955, tuition revenues never covered the cost of educating students at St. Francis. As the Catholic schools evolved and more lay teachers were required due to the shrinking number of ordained religious teaching in the schools, the gap between tuition revenues and the cost to operate the school continued to widen. The Oblates along with the Board of Trustees want to keep tuition prices as affordable as possible for families. A majority of the operating revenues continue to be derived from tuition (60%), and there is a significant percentage that comes from annual contributions including events and fundraisers (26%). Only 4% of the operating revenues are derived from earnings from the SFS Endowment. Thus, Fr. Olszewski has shared a bold vision with many people that will essentially redefine the model of funding for St. Francis and be the leader in how best to fund Catholic education. His dream is big and exciting. It is to shift the reliance on annual tuition dollars as the primary driver of educational excellence. The mission to prepare young men to be leaders in all aspects of life is more important today than ever before. By growing the corpus of the SFS Endowment Fund, and consequently, growing interest earnings that help support annual operations, it will shift the reliance on tuition receipts and annual fundraising dollars as the driver of our sustained excellence. Just by doubling the size of the endowment to \$20 Million, it would generate an extra \$700,000 in interest earnings. Simply growing the Endowment Fund does not mean that students would come to St. Francis for free. It does mean that the school could make broader and deeper life-enriching experiences available for more SFS students regardless of ability to pay. This is a powerful vision and great legacy for Fr. Olszewski and the Oblates.

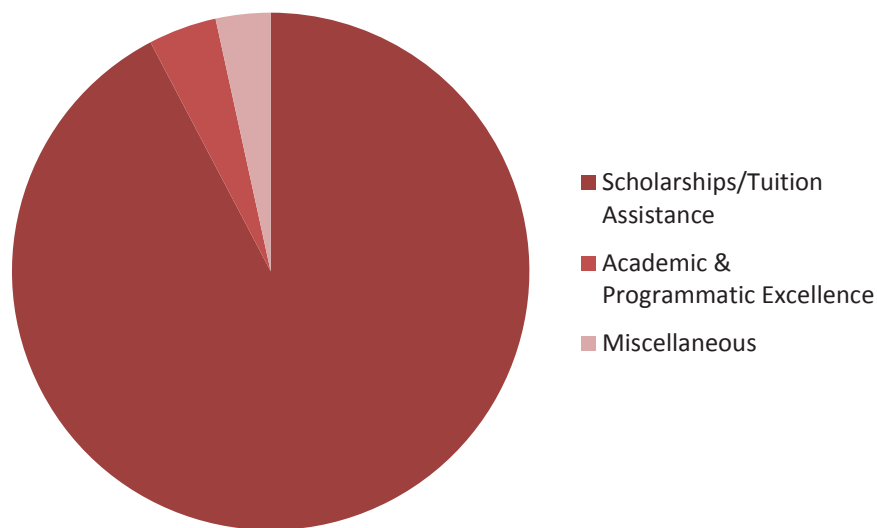

Endowment Allocation

Totaling \$9 Million, excluding various gifts of life insurance and other estate planning gift instruments, the St. Francis de Sales Endowment Fund contains over 100 named funds with various purposes and criteria. An overwhelming majority of the funds created by donors to honor their intent and interests are directed towards tuition assistance and academic scholarships. The purpose of these funds is to provide long-term funding for designated purposes. Donors frequently specify a particular purpose for their gifts, creating endowed funds to fund professorships, scholarships, programmatic excellence, and other miscellaneous purposes.



The Rest of the Story...

It is easy to report anecdotal success of a non-profit organization. Every day there are success stories to report. But the Annual Report provides in greater detail the stewardship of your investments, the outcomes of your generosity, and the rest of the story. St. Francis is in good financial shape. The world of philanthropy has changed dramatically since the last recession. We have made great strides in adapting our operations to become more donor-centric and maximizing investor impact. Our mission is not possible without your support. The Development Office operates with great efficiency. Even by removing the \$1.6 Million Dorothy Wideman estate gift reflected in the Endowment Fund contributions for 2014, it operated at a 15% expense ratio. This means that we spent .15 on the dollar to raise the funds necessary to provide our students with the margin of excellence. Industry benchmarks range from .17-.25. If you include the Wideman estate gift it is a 9% expense ratio. Either way, the office is trying to be as efficient as possible. The school, of course operates in the same capacity. It costs approximately \$12,500 to educate a student at St. Francis and tuition charged in 2013-14 was \$10,300. While it is difficult to truly quantify the true cost to educate a student in the public school system, some estimates report cost of \$18,000-\$20,000 in different school districts around the country. With focus, discipline, and commitment to mission, St. Francis prepares young men exceptionally well for life at a fraction of the cost of its public school counterparts.

A significant portion of the Annual Fundraising revenues includes pledges received from a major gifts initiative, Courage//Leadership//Legacy. A healthy portion of the money received was dedicated to operational initiatives. This stream of income will end in three years. Plans are in progress to replace these revenues with continued emphasis on increasing annual giving support. We invite you to champion an incredibly successful mission, invest in changing lives and providing opportunities for our young men, and invite others to spread the impact of St. Francis de Sales High School. Help guide young men on the transformative journey from boyhood to Christian gentlemen.

St. Francis de Sales High School is supported by alumni, parents, friends, and business and community leaders through annual giving, capital giving, and planned giving. Annual gifts, event income, and interest generated from the endowment fund, enable St. Francis to meet its most pressing needs by funding a portion of the School's annual operating budget.

Donor support is critical to the School's ability to maintain the excellence of a Knight education for this and future generations of young men. St. Francis de Sales High School is most grateful for the kind generosity of its donors and benefactors, past, present and future.

Annual Giving

Annual, unrestricted gifts support the School's core needs including tuition assistance, teacher salaries, facility maintenance, and athletic programs. Every annual gift counts - a \$500 unrestricted annual gift provides a financial benefit to the School that is equivalent to the annual interest income associated with a \$10,000 capital gift to the Endowment Fund.

Capital Giving

Capital gifts to St. Francis de Sales High School are defined as gifts of \$10,000 or more. Often, capital gifts are made on a multi-year pledge basis, typically, five years. Capital gifts

to the School ensure a strong, permanent endowment, help to build and restore campus facilities and sustain a comprehensive range of academic and extracurricular programs. Donors who choose to make capital gifts can direct their support toward a specific purpose that matches their personal interests with the needs and priorities of SFS.

Planned Giving

Bequests, charitable gift annuities, and charitable trusts are all examples of planned gifts. Most planned gifts benefit St. Francis de Sales High School at some point in the future and play a significant role in preserving SFS's excellence for future generations of students.

···· Oblate History ····



The Oblate Fathers were founded in 1876 by Father Louis Brisson; encouraged by Sister Mary de Sales Chappuis. While the Oblate roots stem from France, the religious order migrated to Holland, Germany, Austria, and Switzerland in the late 1800s. It was in 1893 when the Oblates first settled in the United States, first in New York and later in Wilmington, Delaware. It was here that the first permanent Oblate community and school were established. Toledo became home to the Oblates in 1943 when seven Oblates accepted faculty positions at Central Catholic High School.

Central had a serious crowding problem and Bishop George Rehring was interested in providing an all-boy high school for the community. (There were already two all-girl high schools options available.) He asked the Oblates if they would be willing to take on this challenge. The Oblates agreed to build, maintain, and staff the school. St. Francis de Sales High School opened its doors to 290 freshman and sophomore students on September 14, 1955.
